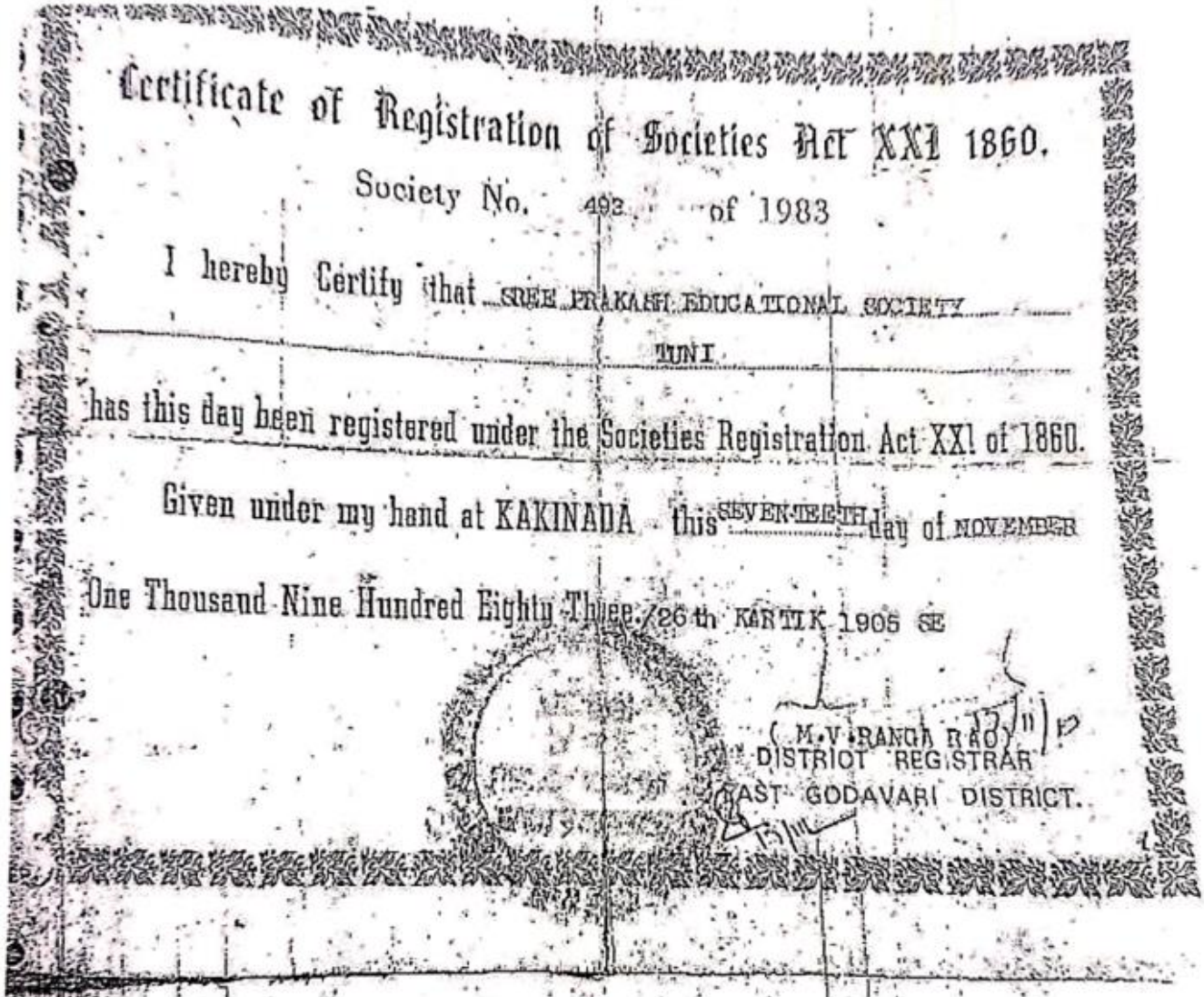

## ARTICLES OF THE SOCIETY

1. The Name of the Institution shall be :

2. LOCATION : The Registered Office of the Society shall be located at Door No. 5-17-20, Kothapeta, Tuni, E.G.Dist, A.P.
3. MEMBERSHIP : The Society shall consist of the following as members.  


A) FOUNDER MEMBERS: The promoter members can be treated as founder members of the society and they can have permanent membership in Governing body.

The following are the PROMOTER MEMBERS.

  1. Sri A.A.Prasad, B.E., S/o Sri A.Venkata Ratnam, Vijayawada
  2. Sri Ch.V.K.Narasimha Rao, B.E., S/o Sri Ch.V.D.Prakasa Rao, Tuni

B) DONORS : Those who pay Rs. 50,000/- and more can be treated as Donor member of the society. They have Permanent membership in the Society.

C) LIFE MEMBERS : Those who pay Rs.25,000/- and more can be treated as life members of the society. They have membership in the general body.
4. Any change in the qualification for membership made in these rules shall take effect only from the date of adoption of these rules as amended and shall not effect the status of the members already enrolled.
5. GENERAL BODY :  
The General Body shall consist of President, Two Vice Presidents, Secretary, Two Joint Secretaries, Treasurer and Members etc.,

## 6. TERMINATION OF MEMBERSHIP :

- a) Any member may resign his membership in writing and his membership shall cease from the date of acceptance of the Governing Body.
- b) Adjudicated as insolvent
- c) If any member in the opinion of the General Body is such that his presence in the General Body is detrimental to the interests of the Society, The General Body may pass a resolution to that effect and remove him from the General Body and his membership shall cease from the date of such resolution.

## 7. POWERS OF GENERAL BODY :

- a) To elect seven (7) members to the Governing Body once in three years from among members under Article 3 C.
- b) To review the activities of the Society and to set up Guidelines and targets for the achievements of the objectives of the Society.
- c) To review and approve the audited statements of Accounts of the previous year.
- d) To discuss and pass annual and revised budget recommended by the Governing body for the ensuing year

## 8. MEETINGS OF THE GENERAL BODY :

- a) The General body shall meet once in a year in the month of October or on any extended date as may be decided by the Governing Body and such meeting shall be called the Annual General Body Meeting.
- b) The General Body shall elect (7) members once in three years to the Governing Body.
- c) If 1/3 or more of the members of the General Body give notice in writing to convene a meeting of the General Body, the Secretary shall do so not later than 21 days after the service of such notice provided the purpose and the subjects to be discussed in the meeting are specifically mentioned in such notice.
- d) Notice of the meeting of the General Body shall be given to the members not less than seven days prior to the date of meeting with the agenda of the subjects to be brought for consideration in such meeting, by certificate of posting or personally.



- C) The Governing Body shall have power to admit members

- E) To employ the requisite staff selected by the selection committees and fix their scales of pay, other allowances and increments.
- F) To grant and / or cancel leaves exceeding three months under the rules prescribed by the Government and University.
- G) To retire the employees, fine, suspend and to dismiss them from their services duly following the prescribed procedure and after obtaining the prior permission of the concerned authorities, if necessary.
- H) To raise funds for the Society and for the Institutions under its management by subscriptions and or by loans.
- I) To acquire or sell properties for the benefit of the Society or Institutions.
- J) To lease out the properties of the Society.
- K) To secure properties and buildings or land on lease for the benefit of the Institutions of the Society.
- L) To pass by laws consistent with the objects of the Society and its Institutions.
- M) It shall have the power to frame, alter or mend the articles of the Society not in consistent of the objects of the Society.
- N) To open accounts in the name of the Society and Institutions in any bank or banks and to operate upon the same.
- O) To prepare the annual and revised budgets and to place them before the General Body for its acceptance.
- P) To appoint qualified auditors.

#### 14. MEETING OF THE GOVERNING BODY :

A) The Governing body shall meet atleast once in six months.

B) The notice of the meeting of the Governing Body shall be given not less than seven days before the date of the meeting except for emergency meetings. Notice can be sent either personally or by certificate of posting.

C) If one third members of the Governing body give notice in writing to convene a meeting of the governing body specifying the subjects to be discussed thereon, the Secretary shall do so within 15 days of such notice.

#### 15. VACANCIES :

Whenever any vacancy in the governing body arises, the Governing body shall co-opt members from among the members of the General Body, such co-opted member or members shall hold office for the unexpired period of the vacancy.

#### 16. QUORUM :

A) The quorum for the meeting of the General Body shall be 3/5<sup>th</sup> of the members.

17. GOVERNING COUNCILS :

- A) The Governing Body can constitute Governing Council for efficiency in running of the Institutions, if necessary.
- B) There shall be Governing Councils for the institutions of Society. The Governing Council shall consists of minimum seven persons. The Governing Council shall conduct affairs of the individual institutions and guide the Secretary & Correspondent to appoint the necessary staff.
- C) The Principal / Head master / Director / Director of Education/ University representatives , Government representatives will be members of respective institutions governing council along with nominated members of General Body.

18. PRESIDENT :

The President shall preside over all the meetings, the General Body and sub committees. The President shall have the right to advise the secretary for the emergency meeting of the General Body or Governing Body or Sub-Committee for transacting the urgent matters.

19. VICE - PRESIDENT :

In the absence of the President, the Vice President shall preside over the meeting and in his absence the second Vice President shall preside over the meeting.

20. SECRETARY :

- A) The secretary shall be the chief executive and shall be incharge of the management of office, of the Society and its institutions.
- B) He shall be the correspondent of the institutions.
- C) The secretary shall convene meetings of the General Body, Governing Body and Sub committees.
- D) The secretary shall prepare the agenda for the meetings of the General Body, Governing Body and Sub-committees.
- E) The secretary shall maintain or cause to be maintained the minutes of the proceedings of all the meetings of the General Body, Governing Body and Sub Committees which shall be signed by the President of the meeting.

- F) The Secretary shall carry out the resolutions passed by the General Body, Governing Body and Sub - Committees.
- G) The Secretary has to place before the governing body every year the revised budget of the academic year and the annual budget of the next academic year relating to its institutions.
- H) The Secretary has to prepare annual report at the end of every academic year regarding the working of the institutions, together with a report from the principal as to the adequacy of staff, strength of the students, income, equipment and furniture, accommodation including buildings, laboratories and library etc.,
- I) The secretary shall maintain all the registers and accounts of the association.
- J) The Secretary shall place before the governing body the detailed statement of Expenditure for its approval.
- K) The secretary shall call for and obtain from the principal all the information and returns required from time to time to correspond with the Government, University and University Grants Commission as the case may be relating to the Institutions.
- L) The Secretary shall have the powers to sanction leaves to the employees, teaching and non teaching staff not exceeding three months at a time.
- M) The secretary can appoint teaching / non teaching staff of the institutions with / without the guidance of Governing Council wherever necessary.
- N) The Secretary shall exercise such other incidental and consequential powers and duties.
- O) The Secretary shall look after the day to day administration of the Institutions.
- P) The Secretary shall have the power to take disciplinary actions against the erring staff, establishment and students.
- Q) The Secretary shall carry out all Government and University orders and proceedings.
- R) The secretary shall be the custodian of all properties of the Association and its institutions.
- S) The secretary shall be co-signatory along with the treasure for the buildings and development fund account of the institution.

T) The secretary can sanction expenditure not provided in the budget to the extent of Rs. 5,00,000 /- at a time in a year for special consignments subject to the ratification by the Governing Body.

U) The secretary shall sue or be sued.

V) The Secretary shall operate the bank account of the Society.

W) The secretary is authorized

a) To raise loans from banks or other financial agencies.

b) To obtain bank guarantees and or enter into any other financial transactions that may be necessary for starting new course and / or for the development of the infrastructural and other facilities of institutions under the management of Sri Prakash Educational Society.

## 21. JOINT SECRETARY :

The Joint Secretary shall assist the Secretary in discharging his duties and also to act as per his directions in his absence.

## 22. TREASURER :

a) The treasurer shall be the chief custodian of funds of the Society.

b) The Treasurer shall be in charge of all cash and finance of the Society.

c) The Treasurer shall maintain such accounts as prescribed by the Governing body.

## 23. THE FUNDS :

The funds shall be spent only for the attainment of objects of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means provided that members working for the Society or its institution may be remunerated as decided by the Governing Body duly ratified by the General Body.

## 24. AMENDMENTS :

No amendment or alteration shall be made in the laws and Bye laws of the Society unless such amendment(s) are ratified by three fifths of members present at a General Body meeting convened for the purpose and confirmed by three fifths of the members present at a special meeting.



The above provisional / temporary affiliation is granted subject to compliance of other conditions as furnished hereunder from the date of issuance of this Order.

- 1 These orders shall be in force for a period of one academic year as indicated in the subject, if the College is permitted to function in rented building. The management should renew their affiliation in each academic year until permanent affiliation is granted.
- 2 The University has the authority and reserves the right to withdraw the affiliation, at any point of time, on any action of the Management / College which damages or causes disrepute to the Government / University and other instrumentality of the State / Central Government.
- 3 The Management / College shall fulfill the deficiencies within a period of three months and send compliance along with documentary evidence to the University, failing which, the University has authority to withdraw its affiliation.
- 4 The management should obtain prior approval from the concerned authority for establishment of the College and offering courses etc before applying for the affiliation, failing which the affiliation accorded is deemed to be cancelled without any further notice.
- 5 The management shall follow the rules issued by the Government / Competent Authority from time to time on all aspects related to the administration of the college.
- 6 The staff appointed should be qualified as per the rules and regulations issued by UGC or concerned Body.
- 7 Infrastructure like Buildings, Land, Playground, Lab equipment, Library, Furniture etc.. should be well maintained for the effective functioning of the College.
- 8 The balance of Corpus Fund, if applicable, should be deposited as per rules in force.
- 9 The management should not change the Programs / Combinations, intake and media etc sanctioned in these proceedings, failing which, such action will be construed as tampering of records for which the University will initiate necessary legal action against the Management.
- 10 The Management shall neither make any excess admissions without approval of the concerned competent authority and the university nor make admissions without affiliation of the University
- 11 The Management shall publish prospectus of its programs offered and all other institutional details along with fee prescribed.
- 12 If the management is permitted to start the College in a rented building, they should construct permanent building for the College in the same mandal within a period of five years.
- 13 The accommodation shown for the College should not be used for any other purpose other than running the college for which permission is given by such Body and the University.
- 14 The management should not make any claim from the Government or instrumentality of the Government for any grant-in-aid either now or in future, if the College is offering unaided Programs.
- 15 The Management (a) should not shift the College to any other place; (b) should not change the name of the College, (c) should not transfer the management of the College and (d) should not convert Women's College to Co-Education and vice-versa (e) shall not mortgage its assets without prior permission of such Body and the university.
- 16 The management of the College shall set up a grievance and complaints cell as per the Supreme Court / UGC guidelines for dealing with sexual harassment / ragging related cases and other grievances etc.
- 17 The management should establish a website for the college and keep all the necessary academic and administrative information in the website.
- 18 The University reserves the right to conduct surprise checks at any time. The University also reserves the right to cancel affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the University, apart from any defaults/irregularities committed which would attract legal proceedings under Law.
- 19 The Management or any other person of the Management of the College shall not collect any capitation fee and the same is prohibited as per AP Capitation fee Act 1983.
- 20 The Management shall not allow malpractices in the examination and the same is prohibited.
- 21 The Management shall ensure the non-availability of carbonated beverages and junk foods around 200 meters of the premises.
- 22 The Management shall not allow the sale of tobacco products in the premises of the College and the same is prohibited.
- 23 The Management shall take measures to safeguard the interests of the students without any prejudice to their caste, creed, religion, language, ethnicity, gender and disability.
- 24 The Management shall get the College accredited by the State / Central Government agencies, after passing out of two batches or six years whichever is earlier, if the College was not accredited.
